Board Resolution of Brookwood Hills Homeowners Association, Inc.

Central Fence Policy

The HOA does not own any of the fencing or the brick walls surrounding our community. Each is privately owned by each homeowner. Currently, our HOA documents require some compliance, but we know it is not definitive. Our documents read as follows:

Section 4.12 Special Fence Requirements. The fee owner of certain particular lots shall abide by specific additional fence requirements and restrictions as shown on the attached Exhibit "B", and as described below:

- (a) <u>Brick Fence Zone</u> In locations so designated on Exhibit "B," the fence shall be constructed of brick and in a uniform manner as specified by the Committee. The fence and its appearance are to be maintained by the Owner.
- (b) <u>Brick Columns with Wood Fence Zone</u> In locations so designated on Exhibit "B," the fence shall be a wood fence, constructed with 6-inch pickets, and at the height of 6-feet, with brick columns spaced a nominal 25 feet. The outward face of the fence shall be painted or stained the color specified by the Committee. The fence and its appearance are to be maintained by the Owner.
- (c) <u>Wood Fence Zone</u> For areas not specifically designated on Exhibit "B", the fence shall be a wood fence, constructed with pickets of 4-inch material or greater, and at the height not to exceed 8-feet. The fence and its appearance are to be maintained by the Owner.

A discussion was held May 2023. The residents on Oak Cove decided to maintain the same fence style since the establishment of the neighborhood in 1986. These standards are requested for the following residential homes in the Brookwood Hills II HOA community.


